Statement of Demands and Needs

This product meets the demands and needs of a pleasure craft owner.

Insurance Undertaking

This insurance is underwritten by Syndicate 2001 at Lloyd's; which is wholly owned and managed by Amlin Underwriting Ltd whose registered address is St Helen's, 1 Undershaft, London EC3A 8ND. Amlin Underwriting Limited is registered with the Financial Services Authority and its registration number is 204918. It is also registered with the Society of Lloyd's and its number is 01901D.

Type of Cover: Inland Policy

This policy summary does not contain the full terms and conditions of your pleasure craft policy, which can be found in the insurance wording.

This is an annual comprehensive insurance policy for pleasure craft used for private pleasure use on inland non-tidal waters of the United Kingdom.

The main characteristics and benefits are:

- Accidental damage cover (see section 2a)
- Theft cover (see section 2a)
- Machinery cover (see section 2a)
- No excess deducted or loss of no claims bonus for damage claims occurring whilst moored or stored ashore at the marina stated on your insurance certificate (see section 2f)
- Third party liability cover (see section 4a)
- Medical costs and personal accident cover (see sections 5a & 5b)

- Road transit cover
- 60 days use within coastal waters of the United Kingdom (see certificate of insurance)

The significant and unusual exclusions are:

- Wear and tear, corrosion, osmosis or electrolysis (see section 2c4)
- Outboard motors which fall into the water, unless they were attached to the vessel or the shore by a safety chain or rope (see section 2c7)
- Accumulation of rainwater in the vessel (see section 2c16)
- Theft as a result of fraud or dishonesty (see section 2d6)
- Any single item of personal belonging worth more than £250 unless declared and agreed by underwriters (see section 3c6), for a full explanation of which personal belongings are not covered (see sections 3c7 to 3c11)
- War and terrorism, except where the exclusion of terrorism risks is banned by law (see sections 7c1 and 7c4)
- The excess is doubled if you make a claim because of an accident in coastal waters (see section 9 3)

Right to Cancellation

You may cancel your insurance by phoning or writing to us.

If you cancel your insurance:

- within 14 days of the beginning of the period of insurance shown on your insurance certificate, we will return the premium you have paid less £30;
- more than 14 days after the beginning of the period of insurance, we will return the premium for the rest of the period of insurance, less £30, as long as this is more than £10. If it is less than £10 we will not return any premium.

If you have made a claim you will not be entitled to any return of premium. If you later make a claim for something which happened before your policy was cancelled, you must repay to us any premium that we returned before we deal with the claim.

There is no return of the document charge.

Premiums

All premiums received by St. Margarets are held by us as agent of the insurer.

Notification of Claims
